Subj: RELOCATION OF COMMANDER, NAVY REGION EUROPE (CNRE)  
AND CHANGE IN REPORTING RELATIONSHIP

1. Purpose. To approve permanent relocation and change in reporting relationship for subject shore activity assigned to the Chief of Naval Operations for command per reference (a).

2. Background. Consolidation of all CNRE staff in Naples, Italy is designed to achieve savings by sighting entire command in a location with a reduced Living Quarters Allowance and Post Allowance cost. The Naples location will also achieve significant travel cost savings as government air operates from that site.

3. Organizational Changes. Relocate Commander, Navy Region Europe from London, United Kingdom to Naval Support Activity, Naples, Italy and change reporting relationship commencing immediately, with completion by 31 July 2004. The following applies:
